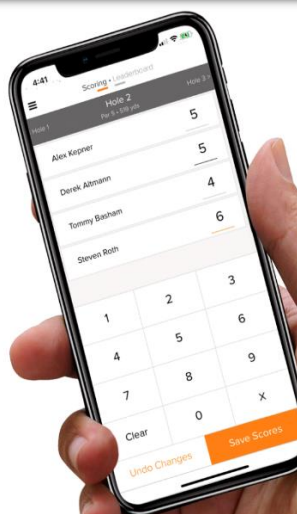




### Mobile app and live scoring

#### TERMS AND CONDITIONS

This agreement is made between Wood Wind Golf Club (hereinafter referred to as "Club") and the undersigned (hereinafter referred to as "Group"). Group agrees that the terms of this Agreement are based upon the information in which they provided above. In the event that the information provided by Group materially changes or is incorrect, then this Agreement may be terminated or modified by Club.

#### PLEASE READ AND INITIAL EACH LINE ACKNOWLEDGING THAT YOU HAVE READ AND UNDERSTAND THE FOLLOWING TERMS AND CONDITIONS

\_\_\_ **PAIRINGS:** In order to adequately prepare for the event, Club requires that pairings be submitted no later than two days prior to the outing. Club staff will make every attempt to accommodate all pairing changes made on the day of the outing, but "last minute" changes may not be reflected in the posted pairing information, personalized scorecards, and cart signs. Please provide pairings in typewritten form to ensure attendee names are spelled correctly.

\_\_\_ **GOLF POLICIES:** Proper golf attire is required which includes collared shirts, non-metal spikes, and slacks or shorts. Denim is not permitted.

\_\_\_ **EXTRA GOLF CARTS:** Wood Wind has 60 golf carts on property. If your group requires additional carts, there is a minimum order of 10 carts. The fee is \$40 per cart, plus drop off/pickup fee.

\_\_\_ **OUTING MINIMUMS and GOLF COURSE EXCLUSIVITY:** Group is required to pay Club the full Guaranteed Amount. Group is required to pay all amounts exceeding the guaranteed amount. Guaranteed amount is based on the final headcount given to the Club seven (7) days prior to the event. Once inside the window of 7 days, the final headcount number cannot be decreased. If Group has less than 72 players, Club may sell starting times to the membership or general public before or after the start of the event. With the exception of the banquet room (and any other portion of the Club reserved for the outing) the Club will remain open to the membership and general public throughout all golf outings.

\_\_\_ **GUARANTEE:** All outings require a final player count seven (7) days prior to the outing. Additions to the guaranteed number will be accepted on a space available basis. Guarantees of attendance are not subject to reduction and Club will charge Group, at a minimum, the amount due in accordance with the guaranteed attendance. If guarantee is not received, the contracted number of guests or revenue minimum will be used as a guarantee.

\_\_\_ **INCLEMENT WEATHER:** Dangerous weather may temporarily suspend play. However, total cancellation of an outing will only occur if Club staff deems the course to be unplayable and unlikely to return to a playable status in a reasonable time to complete the entire outing. Club will make every effort to ensure the outing is played as scheduled. If Club initiates the cancellation of a golf outing due to conditions outlined above, the outing host understands and agrees that the outing fee as outlined within this agreement will still apply. Additionally, should less than 9 holes of golf be completed due to cancellation by Club, rain-check certificates equivalent to the amount of golf not played by each participant will be provided to the outing host.

\_\_\_ **FOOD & BEVERAGE:** We provide a food and beverage selection to fit most budgets and needs. If you are looking for a more extensive food offering, we will connect you with Sahm's Catering, our exclusive catering company to plan your event.

\_\_\_ **FOOD & BEVERAGE (DONATED PRODUCT):** If you have donated lunch, dinner, and/or alcoholic beverages, there is a \$1,000 fee for bringing onto property.

\_\_\_ **DEPOSIT:** Club requires a \$750 deposit due upon signing of the contract. Final payment of your remaining balance is due seven (7) days following your event.

\_\_\_ **CANCELLATION POLICY:** Group agrees that if it cancels this Agreement for any reason, the Club will suffer damages. Signature to 180 days prior to outing (25% of anticipated revenue), 179 days to 120 days prior to outing (50% of anticipated revenue), 119-60 days prior to outing (75% of the total anticipated revenue), and 59 days to the day of the outing (100% of anticipated revenue). Cancellation fee and any related taxes are payable within seven (7) days of the date of cancellation. Deposits paid by the Group will be applied against the Cancellation Fee owed.

\_\_\_ **SHIPMENTS & PACKAGES:** Shipments should arrive no earlier than three (3) days prior to the outing. Club has no liability for delivery, security, or condition of packages. All items brought to Club must be removed from property upon conclusion of outing.

\_\_\_ **DAMAGES & LOSSES:** Group shall be responsible for all damages and losses caused to Club employees or property; or to third persons or their property by Group, its guests or invitees. Group assumes all such liability and expense and agrees that, in addition to any other rights as against such guests or others; Club may charge Group's Master Account or directly bill Group for charges.

\_\_\_ **INSURANCE:** Group agrees that it has procured sufficient insurance to cover the loss of all property of Group and its attendees and invites as well as all liability associated with the event. Group waives any claims under Club's insurance policy for the loss of Group's property or the property of any of its attendees or invites.

\_\_\_ **INDEMNIFICATION & HOLD HARMLESS:** Group agrees to defend, indemnify, and hold harmless Club, its owner and affiliates, and each of their respective shareholders, directors, officers, employees, agents, and representatives from and against all claims, actions, causes of action, liabilities, costs and expenses, including without limitation reasonable attorneys' fees.

\_\_\_ **OUTSIDE CONTRACTORS:** If Group finds it necessary to use outside services, companies, firms, agencies, individuals, and groups hired by or on behalf of Group shall be subject to prior written approval of Club. If Group uses outside contractors, any such contractor must provide Club with evidence of their commercial general liability insurance policy with limits equal to those required of Group. Group bears responsibility for the payment of any charges incurred at Club by its contractors.

\_\_\_ **ENTIRE AGREEMENT:** This agreement constitutes the entire agreement between the parties with respect to the subject matter hereof and supersedes any previous communications, representations or agreements, whether written or oral. Any changes to this Agreement must be made in writing and signed by authorized representative of each party.

\_\_\_ **MISCELLANEOUS:** The person signing this Agreement on behalf of Group warrants that he/she is authorized to bind the Group. Any provision of this Agreement that is deemed unenforceable shall be ineffective to the extent of such unenforceability without invalidating or rendering the remainder of this Agreement invalid.

\_\_\_ **COMPLIANCE WITH LAWS:** Group shall comply with all Federal, State, and local laws, rules and regulations with respect to their activities while on Club property, including obtaining permits required for activities during the outing. Club may require proof of such compliance prior to the outing. Club relies upon Group's attendance projections in reserving the appropriate room(s) and in observing all federal, state and local regulations regarding room capacity limitations and health, safety, and fire codes. Club reserves the right, in its sole discretion, to take any and all actions it deems necessary to cause the outing to be in compliance with all laws, rules and regulations, including without limitation, (1) closing the outing, (2) requiring certain guests leave the outing, (3) restricting access to the outing, (4) restricting the consumption of alcoholic beverages, and (5) monitoring the outing. Such actions of Club shall be without penalty and Group shall remain liable for all obligations under this Agreement.

\_\_\_ **NO ASSIGNMENT:** Group may not assign or transfer this Agreement or any part thereof without the written consent of Club.

\_\_\_ **RIGHT OF INSPECTION/ENTRY:** Club will have the right to enter and inspect all functions. If Club observes any activity which it determines, in its sole discretion, may be illegal or inappropriate, or that may result in harm to persons or objects, Club has the right to immediately cancel the outing, in which case all of Group's guests and invitees must immediately vacate the premises. In such event, Group will remain liable for all fees and charges related to the function pursuant to the terms of this Agreement.
